SUBJECT: AIRPORT RATES, FEES & CHARGES - MAIN TERMINAL

In accordance with the Series 2013 A, B, & C and Series 2019 A & B Revenue Bond Indentures, the A.B. Won Pat International Airport Authority, Guam (GIAA) is required to establish rents and fee sufficient to cover its annual operating costs including the debt service obligation under the aforementioned Bonds.

All airline rents and fees (Main Terminal) are established based on a "cost center compensatory" method whereby user fees and charges are calculated to recover the allocated operating costs of the facilities, which include all debt service obligations. Henceforth, all rates and fees are subject to annual recalculations based on the then current budget requirements. Notice is hereby issued of the following adjusted rates and fees which shall be effective <u>October 1, 2020.</u>


