



## MINUTES OF THE REGULAR MEETING OF THE BOARD OF DIRECTORS OF THE A.B. WON PAT INTERNATIONAL AIRPORT AUTHORITY, GUAM Monday, November 28, 2022, 3:00 p.m. GIAA CONFERENCE ROOMS 1 & 2

#### 1. CALL TO ORDER AND ATTENDANCE

The November 28 regular meeting of the Board of Directors of the A.B. Won Pat International Airport Authority, Guam ("GIAA" or the "Authority") was called to order by Chairman Bamba at 3:24p.m. at the GIAA Terminal Conference Room #3, 355 Chalan Pasaheru, Tamuning, Guam, 96913.

#### 2. APPROVAL OF AGENDA

On motion duly made by Director Weakley, seconded by Vice Chair Sobti, the following resolution was unanimously passed via roll call vote:

#### Resolution No. 23-04

The Board hereby approves the agenda of the November 28, 2022 regular meeting of the Board of Directors, as presented.

#### 3. APPROVAL OF MINUTES

#### A. October 27, 2022 - Regular Meeting

On motion duly made by Secretary Weakley, seconded by Director Morato, the following resolution was unanimously passed via roll call vote:

#### Resolution No. 23-05

The Board hereby approves the minutes of the October 27, 2022 regular meeting, subject to corrections.

#### 4. CORRESPONDENCE

Executive Manager Quinata advised there was no Correspondence to report.

#### 5. OLD BUSINESS

#### A. COVID-19 Rent Relief Discussion

Deputy Executive Manager Hernandez presented a COVID-19 rent relief request for MAG concessionaires (Tenants) for the Board's consideration. The Deputy Executive Manager provided brief background relative to rent relief previously offered to MAG concessionaires. At the July 26, 2022 Regular Board meeting, the Board approved concession MAG tenant relief for the period of January 1, 2022 through June 30, 2022. Management has continued to work closely with MAG tenants, and would like to recommend further rent relief assistance, by extending the same terms, as follows:

• During the relief period, in lieu of MAG, Tenants shall <u>pay the greater of</u>: (i)a percentage of gross sales or (ii) main terminal rent based on space occupied at the airport tariff rate, or (iii) percentage of Monthly MAG as noted below:

#### **SAMPLE**

July 2022 – September 2022 1,263,333.33 x 31.18% 393,907.33

- The relief period is effective July 1, 2022 through September 30, 2022.
- For this relief period, Tenants will at the minimum remit monthly payments based on percentage of gross sales. Tenants may elect to *defer* the difference of percentage of gross sales to percentage of Monthly MAG with any such deferred amounts being due and payable on or before December31, 2022, or sooner upon 30 days written demand by GIAA.
- No late fees or interest under this rent relief period will be assessed for any portion of the deferred rent portion of payments made on or before December 31, 2022, or sooner upon 30 days written demand by GIAA.

The Deputy Executive Manager advised after the first quarter of FY2023, Management will take a look to determine if further relief is necessary.

Vice Chairman Sobti inquired if all tenants are current. The Deputy Executive Manager informed the Board that most, if not all GIAA tenants are current, some have slight receivables. Discussion followed relative to deferment; and impact to Airport and benefit to the tenants.

After further discussion, on motion duly made by Director Morato, seconded by Vice Chairman Sobti, the following resolution was unanimously approved via roll call vote:

#### Resolution No. 23-06

The Board hereby approves the extension of Rent Relief to MAG Concessionaires for the months of July 1, 2022 through September 30, 2022, and further authorizes Management to discuss with MAG Concessionaires a deferral of the difference of percentage gross sales of monthly MAG, payable on or before December 31, 2022, as presented by Management.

#### 6. NEW BUSINESS

A. Approval of 14 CFR Part 150 Noise Compatibility Study (NCP) & Update to Noise Exposure Maps (NEMS) – RFP-003-FY22

The next item requiring Board action was the award for 14 CFR Part 150 Noise Compatibility Study (NCP) & Update to Noise Exposure Maps (NEMS) - RFP-003-FY22. Deputy Executive Manager Hernandez, provided background information to the Board on the referenced RFP, including the scope of services, contract term, dates of advertisement of the RFP, proposal submission deadline, and the number of interested proposers. A total of fourteen (14) firms

showed their interest by obtaining the RFP package, and two (2) firms submitted a proposal before the established deadline. An evaluation committee was established to evaluate the proposals that were submitted based on the evaluation criteria set forth in the RFP. The score sheets were gathered and tabulated by the Procurement Office and the evaluation results in the order of ranking are as follows:

- 1. Offeror A
- 2. Offeror B

14 CFR Part 150 Noise Compatibility Study (NCP) & Update to Noise Exposure Maps (NEMS) contract will be funded under an FAA AIP grant, Federal Share is 90% and Sponsor Share is 10%. Upon Board approval, an agreement will be forwarded to Legal Counsel for review and approval as to form. The term of the agreement is for a period of five (5) years from the effective date of the agreement.

Management recommended that the Board approve the ranking results and the contract award to the best qualified offeror, Offeror 'A', for the 14 CFR Part 150 Noise Compatibility Study (NCP) & Update to Noise Exposure Maps (NEMS) contract, subject to negotiation of fair and reasonable fees to be submitted by the proposer at a time and in a format determined by GIAA. If GIAA is unable to negotiate a contract with the highest ranked offeror, the Executive Manager or designee may enter into negotiations with the next most qualified offeror and so forth consistent with the Guam Procurement Law & Regulations and the RFP.

Director Morato inquired on details of the study, with Mr. Frank Santos advising the Board that the study will include things such as, sound proofing of homes, and adjustment of flight paths. The last study was completed twenty (20) years ago, and approximately two hundred (200) homes were sound-proofed, at an average cost of \$50k per home. Discussion followed relative to sound-proofing homes.

After further discussion, on motion duly made by Director Morato, seconded by Secretary Weakley, the following resolution was unanimously approved via roll call vote:

#### Resolution No. 23-07

The Board hereby approves the ranking results as presented and the contract award to Offeror 'A' for 14 CFR Part 150 Noise Compatibility Study (NCP) & Update to Noise Exposure Maps (NEMS) — RFP-003-FY22, subject to Management's negotiation of fair and reasonable fees and review by Legal Counsel. If GIAA is unable to negotiate a contract with the highest ranked offeror, the Executive Manager or designee may enter into negotiations with the next most qualified offeror and so forth consistent with the Guam Procurement Law & Regulations and the RFP.

Deputy Executive Manager Hernandez announced that Offeror 'A' is AECOM.

B. CIP Modification – Rehabilitate Runway 6L/24R Phases 1a and 1b – Proposed Change Order No. 6

Executive Manager Quinata announced that Management would like to request to table CIP Modification – Rehabilitate Runway 6L/24R Phases 1a and 1b – Proposed Change Order No. 6, until a later Board meeting.

#### 7. REPORT OF THE EXECUTIVE MANAGER

Reference is made to the Executive Manager's Report included as part of the Board's packet, which was presented by Executive Manager Quinata. The report included brief updates on Airport flight operations, CIPs and Regulatory updates.

#### 8. REPORT OF THE COMPTROLLER

Ms. Antoniette Bautista, Acting Comptroller reported on the revenues and expenses of the Authority as of October 31, 2022. Ms. Bautista reported that year-to-date Total Signatory Revenues are below budgeted revenues by 20.1%, year-to-date Total Concession Revenues and Passenger Facility Charges are below budget by 5.2% and 40.5%, respectively. Year-to-date Total Other Revenues, inclusive of non-signatory and non-airline revenues are below the budget estimate by 24.6%. Year-to-date Total Operating Revenues Actual of \$4.2M is 15.2% below the budget estimate of \$4.9M. Year-to-date Total Operating Expenses are below budget by 4.2%. Components of this line item include a 6.5% decrease in Personnel Services, a 24.9% increase in Contractual Services, a 61.2% decrease in Materials & Supplies, and a 0% decrease in Equipment/Furnishings from budgeted amounts for these respective categories. The actual year-to-date Net Revenues from Operations of \$0.7M reflects a decrease of 54.6% over the year-to-date budgeted amount of \$1.6M. Ms. Bautista reported that the year-to-date Debt Service Coverage is at 1.45 versus the requirement of 1.25.

Brief discussion followed relative to contractual services, with Deputy Executive Manager Hernandez announcing the increase of power consumption is due to increase in flight arrivals, along with the new ARFF station now being online.

#### 9. EXECUTIVE SESSION

Executive Manager Quinata announced there would be no Executive Session.

Director Weakley inquired on the Art program. Executive Manager Quinata announced that GIAA is working with CAHA to draft an MOU, for displays of local art within the Airport.

Director Weakley asked for an update of the Terminal Roof Repair, with Deputy Executive Manager Hernandez advising the Board that the fees for the A/E phase are currently being negotiated, and an RFP for the construction portion is being finalized. Discussion followed relative to CIP.

#### 10. PUBLIC COMMENTS

There were no Public Comments.

#### 11. ADJOURNMENT

Motion to adjourn duly made by Director Weakley, seconded by Vice Chair Sobti;motion unanimously passed. The meeting was adjourned at 3:55 p.m.

Micah Parsons and Dorance Armstrong had two sacks apiece in the fifth-largest loss



ever for the Vikings and the biggest road win in Cowboys history.

The Vikings (8-2) have been the king of the comebacks in an

NFL season featuring the smallest average winning margin in 90 years, none more remarkable than last week at Buffalo when they turned a 17-point

But the Cowboys carried out a near-perfect game plan with sons forced with a stunning ease. Dallas

gained 108 yards on the ground in the first half. Pollard, the Cowboys' most dangerous weapon on offense all year, finished with six catches for 109 yards and 15 rushes for 80 yards.

Dallas held Justin Jefferson to 33 yards on three catches. Kirk Cousins went 12 of 23 for 105 yards and a lost fumble that Parblind-side sack.

#### 4. CORRESPONDENCE

A. Air Vietnam Aviation Joint Stock Company – Request for Ground Lease

The next item requiring board discussion was correspondence from Air Vietnam Aviation Joint Stock Company (AVAJSC). Executive Manager Quinata advised the Board that he along with Mr. Frank Santos had met with AVAJSC while on a recent trip to the Philippines. AVAJSC is now officially requesting for a long-term ground lease to develop hangars and support facilities for a Maintenance, Repair and Overhaul (MRO) operation for their aircraft and 3<sup>rd</sup> party carriers. The Company envision a 3-bay, wide-body hangar with a projected development cost of more than \$280M. The Manager announced AVAJSC's desire to visit Guam in the near future for a site visit.

Chairman Bamba asked for clarification on what exactly is being requested, as the letter states a request for formal dialogue with the Governor of Guam and her economic development team. Executive Manager replied that AVAJSC's site visit would be to meet with Island leaders, and of course the Airport, to discuss the objective. The Manager expressed what a good opportunity this would be for the Airport, and added that Legislative Bill 342-36, Relative To The Antonio B. Won Pat International Airport Authority, Guam Contracts For The Use Of Airport Facilities And Properties, will allow GIAA to proceed with this request. Public Hearing on Bill-36, introduced by Senator San Agustin was held on October 19, 2022. Chairman Bamba expressed the need for Management and the Board to discuss how to respond to the request and provide updates to any potential investors such as AVAJSC. Brief discussion followed relative to Bill 342-36.

#### 5. OLD BUSINESS

Executive Manager Quinata advised there was no Old Business to report.

#### 6. **NEW BUSINESS**

**A.** CIP Modification – Rehabilitate Runway 6L/24R Phase II – Construction Management Services Extension

Next on the agenda was a CIP Modification, Work Order (WO) No. 006 for Rehabilitate Runway 6L/24R Phase II, Project No. GIAA-FY18-01-2 and funded under AIP No. 3-66-0001-110-2021. Mr. Santos presented the Modification for the Board's consideration:

• Work Order No. 006: SSFM International, Inc. for Construction Management (CM) Services extension from September 12, 2022 to October 31, 2022. The WO for the referenced project is in the Amount of \$180,852.39, subject to FAA approval and funding, and reconciliation of costs. Mr. Santos explained that the Contractor is working on justification for extension past September 11, 2022, which is yet to be resolved. To continue services of the CM, the extension is required. Mr. Santos provided details should the Contractor not be able to provide sufficient justification, because the project is not completed. Based on the latest schedule, the project is anticipated to continue through January 2023. Therefore, Mr. Santos anticipates additional extension modifications to be brought to the Board, based on construction delays incurred by the Contractor. Discussion followed relative to the delays and details of funding.

After further discussion, on motion duly made by Secretary Weakley, seconded by Director Tainatongo, the following resolution was unanimously approved via roll call vote:

#### Resolution No. 23-03

The Board hereby approves Work Order No. 006 for Rehabilitate Runway 6L/24R Phase II, Project No. GIAA-FY18-01-2, in the amount of \$180,852.39, to SSFM International, Inc.

#### 7. REPORT OF THE EXECUTIVE MANAGER

Reference is made to the Executive Manager's Report included as part of the Board's packet, which was presented by Executive Manager Quinata. The report included brief updates on Airport operations, CIPs and Regulatory updates.

Director Weakley inquired on the stage for the Terminal roof Repair project and the amount proposed for the project. Mr. Frank Santos provided a brief update, stating that the design RFP was issued, a designer was selected and approved by the Board, negotiations occurred and

currently the scope and fee proposed, is under evaluation by the Airport.

Brief discussion relative to seat capacities, with Ms. Rolenda Faasuamalie advising the Board that an increase or decrease depends on demand and seasonality.

#### 8. REPORT OF THE COMPTROLLER

Ms. Danielle Camacho, Acting Accounting Supervisor reported on the revenues and expenses of the Authority as of September 30, 2022. Ms. Camacho reported that year-to-date Total Signatory Revenues are below budgeted revenues by 56.5%, year-to-date Total Concession Revenues and Passenger Facility Charges are below budget by 46.3% and 65.3%, respectively. Year-to-date Total Other Revenues, inclusive of non-signatory and non-airline revenues are above the budget estimate by 77.5%. Year-to-date Total Operating Revenues Actual of \$47.4M is 22.2% below the budget estimate of \$60.9M. Year-to-date Total Operating Expenses are below budget by 13.3%. Components of this line item include a 6.3% decrease in Personnel Services, a 16.7% decrease in Contractual Services, a 29.8% decrease in Materials & Supplies, and a 93.8% decrease in Equipment/Furnishings from budgeted amounts for these respective categories. The actual year-to-date Net Revenues from Operations of \$6.3M reflects an decrease of 53.5% over the year-to-date budgeted amount of \$13.6M. Ms. Camacho reported that the year-to-date Debt Service Coverage is at 2.33 versus the requirement of 1.25.

#### 9. EXECUTIVE SESSION

Executive Manager Quinata announced there would be no Executive Session.

#### 10. PUBLIC COMMENTS

There were no Public Comments.

#### **Purpose**

Board action is requested to approve the ranking results and award for Request for Proposals (RFP) No. RFP-003-FY22 for 14 CFR Part 150 Noise Compatibility Study (NCP) and Update to Noise Exposure Maps (NEMS).

#### **Background**

The referenced Request for Proposals (RFP) solicits interest from qualified firms and/or individuals to conduct a Federal Aviation Regulation (FAR) 14 CFR Part 150 Noise Compatibility Study (NCP) and update to Noise Exposure Maps (NEM) for the Antonio B. Won Pat International Airport, Guam ("GIAA").

#### **Procurement Background**

The above referenced RFP was advertised in the local newspapers on September 29 and October 10 and 25, 2022. The established deadline to submit the proposals was November 1, 2022, at 4:00 p.m.

A total of fourteen (14) firms and/or individuals downloaded the RFP package and two (2) firms submitted a proposal before the submission deadline.

#### **Proposal Analysis and Evaluation**

The Evaluation Committee appointed by me completed their evaluations of the proposals and the evaluations were based on the criteria set forth in the RFP. The score sheets were gathered and tabulated by the Procurement Office and the evaluation results in the order of ranking are as follows:

- 1. Offeror A
- 2. Offeror B

The proposals were reviewed to determine responsiveness, that is, whether or not the offeror submitted all documents required by the RFP. All offerors submitted the required documents and were determined to be responsive and responsible as outlined in the Guam Procurement Law & Regulations, subject to the following:

#### **Executive Summary**

RFP No. RFP-003-FY22, Project No. GIAA-FY20-03-6, AIP No. 3-66-0001-TBD, 14 CFR Part 150 Noise Compatibility Study (NCP) and Update to Noise Exposure Maps (NEMS)

#### Offeror A:

Offeror A submitted all required documents set forth in the RFP, however with regard to the required *Certification of Proposer Regarding Tax Delinquency and Felony Convictions* ("Certification"), it was determined that Offeror A submitted the form in their proposal, but upon further review, it was discovered that Offeror A failed to mark the appropriate box indicating the firm's federal tax liability status and any confirmed felony convictions. Therefore, pursuant to **5 GCA § 5216(d) and 2 GAR Div. 4 § 3114(i)(1)**, GIAA determined this mistake was immaterial and had requested that Offeror A submit a corrected Certification. There is no doubt that this was a clerical oversight and Offeror A was intended to be bound by all contractual documents of the RFP.

Offeror A has submitted the corrected Certification. GIAA allowing Offeror A to correct this immaterial mistake does not prejudice the other offerors. Following Offeror A's submission of its corrected Certification, its proposal was determined to be responsive.

#### Offeror B:

Offeror B's proposal was deemed to be responsive based on the submittal of all required documentation set forth in the RFP.

#### **Legal Review**

Upon Board approval, an agreement will be forwarded to Legal Counsel for review and approval as to form. The term of the agreement is for period of five (5) years from the effective date.

#### **Financial Review**

The 14 CFR Part 150 Noise Compatibility Study (NCP) and Update to Noise Exposure Maps (NEMS) will be funded under an FAA AIP grant, Federal Share is 90% and Sponsor Share is 10%.

#### Recommendation

I recommend that the Board approve the ranking results and the contract award to the best qualified offeror, **Offeror A**, for the 14 CFR Part 150 Noise Compatibility Study (NCP) and Update to Noise Exposure Maps (NEMS) contract, subject to negotiation of fair and reasonable fees to be submitted by the proposer at a time and in a format determined by GIAA. If GIAA is unable to negotiate a contract with the highest ranked offeror, the Executive Manager or designee may enter into negotiations with next most qualified offeror and so forth consistent with the Guam Procurement Law & Regulations and the RFP.

Page 2 – Operating Results as of October 31, 2022

Year-to-date Total Signatory Revenues for the month ending October 31, 2022 are below Budgeted revenues by **20.1%**. Signatory revenue estimates are based on projections submitted by Signatory airlines and adopted in the annual budget.

Year-to-date Total Concession Revenues are **5.2%** above budget while Passenger Facility Charges are below the budget estimate by **40.5%**.

Year-to-date Total Other Revenues, inclusive of non-signatory and non-airlines revenues, are below the budget estimate by **24.6%**.

Year-to-date Total Operating Revenues actual of \$4.2M is 15.2% below the budget estimate of \$4.9M.

Year-to-date Total Operating Expenses are above budget by **4.2%.** Components of this line item include a **6.5%** decrease in Personnel Service, a **24.9%** increase in Contractual Services, a **61.2%** decrease in Materials & Supplies and a **0%** decrease in Equipment/Furnishings from budgeted amounts for these respective categories.

The actual year-to-date Net Revenues from Operations of **\$0.7M** represents a **54.6%** decrease over the year-to-date budgeted amount of **\$1.6M**.

Finally, our year-to-date results for Debt Service Coverage is at 1.45 versus the requirement of 1.25.
